Applications are being invited from interested retired Officers of OSS cadre having experience in dealing financial matters of Government Departments, tenders in works contract, OPWD Codal and Contractual matters, not above the age of 62 years and having good service records and physical fitness for engagement of 01(one) No. of OSD (officer-on-Special Duty) on contractual basis in Works Department in terms of comprehensive guidelines of G.A. & PG Department Resolution No.23750/Gen, dtd.27.08.2014, Finance Department O.M. No.7022/F, dtd.17.03.2018 .

2. The contractual engagement will be initially made for a period of one year, and may be extended by further period of one year subject to satisfactory performance and shall not be extended beyond the age of 65 years. The tenure of engagement shall not exceed more than 4 years including all spells taken together. The competent authority reserves the right to terminate the engagement at any time by giving one month written notice to the appointee. On the contrary, if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.

3. The retired officer against whom a Vigilance Case or Departmental Proceeding or Criminal Prosecution is contemplated or pending or who has been penalized for misconduct during the period up-to five years preceding to his / her retirement or is associated with any Political Party shall not be considered for re-engagement.

4. The amount of remuneration of the contractual employee will be fixed as per Finance Department vide their O.M. No.7022/F, dtd.17.03.2018.

5. The period of contractual engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefit.


6. The reengaged officer shall subject to and abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining the duty with regard to the truth and correctness of the information furnished by him / her.




