Sub:- Amendment to codal provision for execution of works under "AMA Hospital" initiatives.

After careful consideration, Government have been pleased to delegate the following financial powers to the Divisional Officers functioning under R&B/ RW Divisions in respect of works executed under "AMA Hospital" Initiatives with regard to technical sanction under Para 6.3.2 and finalization of tender under Para 6.3.15 of OPWD Code, Volume-I.

2. The present delegation is specific to projects to be executed under "AMA Hospital" Initiatives and it shall come into effect from the date of issue of this Office Memorandum.

3. The Superintending Engineer/Executive Engineer of the Division shall finalize the tender through committee constituted with Superintending Engineer/Executive Engineer of the Division as Chairman, Sr. DAO/DAO of the Division as Member, Assistant Executive Engineer/Assistant Engineer of the Sub-Division to the jurisdiction of whom the work relates as Member.

4. Codal provisions under Para 3.5.18 (Note-iii) of OPWD Code, Volume-I for acceptance of single tender, Para 3.5.9 of OPWD, Volume-I and other relevant existing codal provisions in the matter of accordance of Technical Sanction and finalization of tenders shall be strictly followed by the Superintending Engineer/Executive Engineer of the Division in case projects to be executed under "AMA Hospital" Initiatives.

5. Tender shall be invited in most transparent manner adhering to codal provisions to the composite estimates (Civil, Electrical & PH) after accordance of Administrative Approval, Technical Sanction.

6. Under no circumstances, the estimate shall be splitted up for accordance of Technical Sanction and invitation of tender.
