**Sub: - Special Provisions for Restoration Work Post Extremely Severe Cyclonic Storm "FANI".**

In view of expeditious execution of restoration work of post extremely severe Cyclonic Storm "FANI", Government have been pleased to extend the following Special Provisions in relaxation to Provisions in OPWD Code Vol.-II, Appendix-VII for award of works without calling up of tenders.

- (i) Under Para 4 (vi): The time limit for completion of works shall ordinarily be not more than one month for works costing up to Rs. 5.00 lakh. The time limit for works costing more than Rs.5.00 lakh up to Rs.20.00 lakh shall not exceed two months.
- (ii) Under Para 4 (vii): Estimate shall not be split up to bring a particular portion of work within the powers delegated for award of works without calling for tenders, except where splitting up of work is in the public interest for smooth and expeditious execution of work; provided that the authority for such splitting up of work costing up to Rs.20.00 lakh will be exercised by the Engineer-in-Chief/ Chief Engineer.
- (iii) Under Para 6: Financial powers of Chief Engineer of PWD to award works without calling tenders shall be as follows :-
  - a. Chief Engineer – Works costing up to Rs.5.00 lakh
  - b. For all other works costing beyond Rs. 5.00 lakh, approval of Government shall be taken.
- (iv) In case of emergency, works can be awarded to any higher class of contractors irrespective of the financial thresholds/ limits prescribed under Appendix-VIII of OPWD Code Vol-II ensuring the availability of required equipments, tools and machineries etc. This decision for selection of a contractor shall be with the approval of the respective Chief Engineer.
- (v) The upper limit of Rs.20.00 lakh is fixed for a single work to be assigned under these provisions.


