Consequent upon receipt of report from the Collector, Malkangiri through Home(Elections) Department regarding non-cooperation of Sri Sasanka Sekhar Shukla, Assistant Executive Engineer, (R&B) Sub-Division-2 Malkangiri, under Malkangiri (R&B) Division in election work, Sri Shukla was placed under suspension with effect from Dt. 08.11.2018 vide Works Department Office Order No. 16744 dt.08.11.2018.

Pending initiation of departmental action against him, Sri Sasanka Sekhar Shukla, Assistant Executive Engineer(Civil)(Under Suspension) is reinstated into Government Service with effect from the date he actually joins in duty.

On reinstatement, Sri Sasanka Sekhar Shukla, Assistant Executive Engineer (Civil) is posted as such in the office of the E.I.C. (C), Odisha, Bhubaneswar until further orders.

Necessary orders for treatment of the period of his suspension will be issued after finalisation of the disciplinary action contemplated against him.
