**AND WHEREAS**, Sri Agrawal, C.E(Retired) submitted his written statement of defence on dtd.04.10.2017 denying all the charges framed against him.

**AND WHEREAS**, the Commissioner Departmental Inquiries(C.D.I), G.A & P.G Department was appointed as Inquiring Officer u/r-15(4) of the O.C.S(CC&A) Rules, 1962 vide this Department Office Order No.16910 dt.27.11.2017 to inquire into the charges.

**AND WHEREAS**, the Inquiring Officer submitted his inquiry report to this Department vide his letter No.374/CDI dtd.27.02.2020.

**AND WHEREAS**, Sri Agrawal, C.E(Retired) retired from Government Service on attaining the age of superannuation w.e.f 28.02.2019. Therefore, the proceedings has been converted to deemed proceedings u/r-7 of the O.C.S(Pension) Rules,1992 r/w rule-15 of O.C.S(CC&A) Rules, 1962 vide this Department office order No.10126 dtd.17.08.2020.

**AND WHEREAS**, a copy of the Enquiry Report was supplied to the Delinquent Officer Sri Agrawal, C.E(Retired) u/r-15(10)(i)(a) of the O.C.S(CC&A) Rules, 1962 vide this Department Memo No.10201 dtd.17.08.2020 with an advice to submit his representation, if any, on the same.

**AND WHEREAS**, the Delinquent Officer Sri Agrawal, C.E(Retired) submitted his reply to the first show cause notice on dtd.26.09.2020.

**NOW THEREFORE**, after careful consideration of the findings of Inquiring Officer Vis-à-vis charges framed against Sri Agrawal, C.E(Retired), statement of defence and show cause reply of the delinquent officer, Government have been pleased to drop the proceedings and **exonerate** the delinquent officer Sri Ratan Kumar Agrawal, Ex-C.G.M (Civil), IDCO, now Chief Engineer(Retired) from all the charges.
