OFFICE ORDER

No. WORKS-CON-CASE5-0050-2018 2734/W., Bhubaneswar, Dated the ^{26th} Feb, 2021.

WHEREAS, basing on the allegation of non-handing over of the charges of Estimator of Baliguda (R&B) Division causing serious dislocation of works & remaining absent from Government duty unauthorisedly, Ch. Chittaranjan Patra, Ex-J.E(C) was placed under suspension vide Order No.5261 dtd.04.02.2008 of the E.I.C(C), Odisha, Bhubaneswar.

WHEREAS, a disciplinary proceedings was drawn up against Ch. Chittaranjan Patra, Ex-J.E(C) vide Memorandum No.32197 dt.11.07.2008 of the E.I.C(C), Odisha u/r-15 of the O.C.S (CC&A) Rules,1962.

AND WHEREAS, Ch. Chittaranjan Patra, Ex-J.E(C) submitted his written statement of defence on dtd.23.09.2008 denying all the charges framed against him.

AND WHEREAS, the Superintending Engineer, Jeypore (R&B) Circle was appointed as Inquiring Officer u/r-15(4) of the O.C.S(CC&A) Rules, 1962 vide Order No. 47112 dtd.20.10.2008 of E.I.C(C), Odisha, Bhubaneswar to inquire into the charges.

AND WHEREAS, Ch. Chittaranjan Patra, Ex-J.E(C) was reinstated in Government service vide Order No.30142 dtd.24.07.2009 of the E.I.C(C), Odisha, Bhubaneswar.

AND WHEREAS, the Inquiring Officer submitted his Enquiry Report vide his letter No. 33(con) dated 04.06.2015 to the E.I.C(C), Odisha, Bhubaneswar.

AND WHEREAS, a copy of the Enquiry Report was supplied to the Delinquent Officer vide Memo No. 30082 dtd.23.07.2015 of the E.I.C(C), Odisha, Bhubaneswar with an advice to submit his representation, if any, on the same.


AND WHEREAS, the Delinquent Officer Ch. Chittaranjan Patra, Ex-J.E(C) did not submit reply to the first show cause notice.

AND WHEREAS, the E.I.C.(Civil), Odisha, Bhubaneswar transferred the matter to this Department vide his Letter No.13550 dated 27.03.2018 for finalisation of the same at this level.

AND WHEREAS, the Government have proposed to impose penalties on the delinquent officer Ch. Chittaranjan Patra, Ex-J.E(C) i.e. (i) Censure, (ii) Stoppage of one increment with cumulative effect & (iii) The period of suspension may be treated as such.

AND WHEREAS, the 2nd show cause notice was served on Ch. Chittaranjan Patra, Ex-J.E(C) vide this Department Memo No.4802 dtd.08.04.2019 u/r-15(10)(i)(b) of the O.C.S.(CC&A) Rules, 1962.

AND WHEREAS, Ch. Chittaranjan Patra, Ex-J.E(C) retired on dtd.31.03.2019 and expired on dtd.12.07.2020 before finalisation of the proceedings.

NOW THEREFORE, after careful consideration of sad demise of the delinquent officer Government have been pleased to drop the disciplinary proceedings drawn vide Memorandum No.32197 dt.11.07.2008 of the E.I.C(C), Odisha against Late Ch. Chittaranjan Patra, as per the provision contained in G.A. Department circular No.19806/Gen. dtd.21.08.2012.

But his suspension period will be treated as such on account of establishment of the charges levelled against him.






