OFFICE ORDER

No. WORKS-CON-CASE5-0045-2019 2739/W., Bhubaneswar, Dated the 26th Feb. 2021.

WHEREAS, Ch. Chittaranjan Patro, Ex-J.E(C) was placed under suspension vide Office Order No.43526 dt.06.11.2004 of the E.I.C(C), Odisha, Bhubaneswar due to non-handing over of charges of West & Store (R&B) Section of Ganjam (R&B) Division causing serious dislocation of works and remaining absent from Government duty unauthorisedly.

WHEREAS, a disciplinary proceedings was drawn up against Ch. Chittaranjan Patro, Ex-J.E(C) vide Memorandum No.43531 dt.06.11.2004 of the E.I.C(C), Odisha U/r-15 of the O.C.S (CC&A) Rules,1962 for the above lapses.

AND WHEREAS, Ch. Chittaranjan Patro, Ex-J.E(C) submitted his written statement of defence on dtd.16.01.2005 denying all the charges framed against him.

AND WHEREAS, the Executive Engineer, Phulbani (R&B) Division was appointed as Inquiring Officer u/r-15(4) of the O.C.S(CC&A) Rules, 1962 vide Order No. 6913 dtd.18.02.2005 of the E.I.C(C), Odisha, Bhubaneswar to inquire into the charges.

AND WHEREAS, Ch. Chittaranjan Patro, Ex-J.E(C) was reinstated in Government service vide Order No.32550 dtd.04.08.2005 of E.I.C(C), Odisha, Bhubaneswar.

AND WHEREAS, the Inquiring Officer submitted his Enquiry Report vide his letter No. 53 dtd.22.07.2006 to the E.I.C(C), Odisha, Bhubaneswar without submitting his recommendation.

AND WHEREAS, the Inquiring Officer was again requested by the E.I.C(C), Odisha to furnish his recommendation regarding punishment to be inflicted on the delinquent officer and the Inquiring Officer vide his letter No.5 dtd.17.02.2007 submitted his views regarding proposed punishments.

AND WHEREAS, as per advice of the Inquiring Officer, the E.I.C(C), Odisha, Bhubaneswar vide his letter No.13324 dtd.28.03.2007 requested the Executive Engineer, Ganjam (R&B) Division No.-I to intimate the exact amount of loss caused due to nonhanding over of the charges by Ch. Chittaranjan Patro, Ex-J.E(C).

AND WHEREAS, the Executive Engineer, Ganjam (R&B) Division No.-I vide his letter No. 6699 dtd.07.05.2019 intimated to E.I.C(C), Odisha that the exact amount of loss for which Ch. Chittaranjan Patro, Ex-J.E(C) accountable is Rs.1,20,912/-.

AND WHEREAS, the E.I.C.(Civil), Odisha, Bhubaneswar transferred the matter to this Department vide his Letter No.21033 dtd.15.05.2019 for finalisation of the same at this level.

AND WHEREAS, Consequent upon the retirement of Sri Ch. Chittaranjan Patro, Ex-J.E(C) with effect from dtd.31.03.2019, the proceedings has been treated as deemed proceedings u/r-7(2)(a) of the O.C.S(Pension) Rule, 1992 r/w rule-15 of O.C.S(CC&A) Rules 1962 and a copy of the Enquiry Report was supplied to the Delinquent Officer vide this Department Memo No. 12494 dtd.01.10.2019 u/r-15(10)(i)(a) of the O.C.S.(CC&A) Rules, 1962 with an advice to submit his representation, if any, on the same.

AND WHEREAS, no representation was received from the delinquent officer and in between he has expired on dtd.12.07.2020.

NOW THEREFORE, after careful consideration of sad demise of the delinquent officer Government have been pleased to drop the disciplinary proceedings drawn up vide Memorandum No.43531 dt.06.11.2004 of E.I.C(C), Odisha against Late Ch. Chittaranjan Patro, as per the provision contained in G.A. Department circular No.19806/Gen. dtd.21.08.2012.

But, his suspension period will be treated as such on account of establishment of the charges levelled against him.


