RESOLUTION

After careful consideration, Government in Works Department have been pleased to accord approval for establishment of Project Management Unit for a period of 4 (four) years for implementation of the project – "Biju Expressway II".

The PMU will be exclusively entrusted with the task of execution of the project "Biju Expressway II" from Jeypore to Berhampur covering a road length of 317.853 km (Appx.). The PMU will be headed by an officer in the rank of Chief Engineer and will function in the office of the EIC (Civil), Odisha.

The constitution of the PMU & the function it will discharge are as under:

1. It will cover all activities relating to Project Management, Supervision, Monitoring, Quality Assurance & Safety Compliance, Contract Administration.
2. It will monitor all activities relating to Project Management, Land Acquisition, Forest Diversion, Environment and Social Impact Assessment, Finance and Litigation Management.
3. It will formulate action plan in co-ordination with other Departments and other stake holders.
4. It will monitor the co-ordination activity on monthly basis.
5. It will Identify the issues and mitigation measures to be taken.
6. The period of continuation of the PMU may be further extended basing on exigencies of circumstances.
7. The PMU shall be manned by both regular Govt. employees and outsourced personnel, to be outsourced through OB&CC.
8. The expenditure towards pre-project preparedness i.e. DPR preparation, alignment survey, forest survey, forest clearance, land acquisition etc. will be met out of existing Budget provision during 2023-24 available under "3010-Biju Expressway Projects".
9. Any other work assigned related to above mentioned activities.

This has been concurred by Finance Department in their OSWAS File No.FIN-WF1-MISC-0079-2023.
