The above re-engagement is subject to the following terms and conditions.

- The re-engagement is made for a period of one year or till the vacancy is filled up on regular basis, whichever is earlier.
- The re-engagement may be terminated by Works Department at any time for dissatisfactory performance, on notice of one month. In case of any misconduct including misappropriation, negligence in duty or causing loss to the Government, the service may be terminated without any prior notice.



- iii. Besides the action under condition (ii) above, the re-engaged Officers shall also be liable to proceeded against under the provision of the Odisha Pension Rule for any act of misconduct during the course of discharging duties under re-engagement.
- iv. General instructions of Government regarding terms & conditions for re-engagement of Officers as issued from time to time will be applicable and binding on Officers.
- v. In case they desire to resign from the Govt. Offices, they may do so by giving a notice of one month in writing to the Principal Secretary to Govt., Works Department, under intimation to the Controlling Officer. After expiry of the notice period, the Officers may be relieved after handing over the full charges of the records and cash/Bank Accounts to the Relieving officer as decided by Works Department or the Controlling Officer.
- vi. The re-engaged Officers shall be subject to and will abide by the Conduct Rules applicable to the Govt. Servants.
- vii. These terms & conditions are subject to Codal Provisions/ Memorandums/ Resolutions issued by G.A & P.G. Department/ Finance Department/ Works Department from time to time.
- viii. The re-engaged Officers are entrusted with the powers and responsibilities as indicated at para 2.2.62, 2.2.64, 2.2.65 and 2.2.66 of OPWD Code Vol-I.
- ix. These retired engineers are re-engaged against the vacant posts of JE/AEs and their remuneration will be governed by F.D.O.M. No.7022/F., dated 17.03.2018.
- x. Further any addition in terms and conditions will be intimated.
