Case No.06 dated 04.02.2020 u/s 7 of the Prevention of Corruption (Amendment) Act, 2018 against Sri Basudeb Prasad Sahoo, Ex-Assistant Engineer, Soro (R&B) Section under Balasore (R&B) Division-I, Dist-Balasore and subsequent detention in judicial custody for more than 48 hours, Sri Sahoo was placed under deemed suspension with effect from 05.02.2020 vide this Department Office Order No.3959 dated 28.02.2020 in terms of Sub-rule-2 of rule-12 of the Odisha Civil Services (CC&A) Rules, 1962.


Pending finalisation of the above Vigilance Case and Departmental Proceedings drawn up under rule-15 of the Odisha Civil Services (CC&A) Rules, 1962 vide this Department Memorandum No. 10190 dated 17.08.2020 against him, Sri Basudeb Prasad Sahoo, Ex-Assistant Engineer, Soro (R&B) Section under Balasore (R&B) Division-I, Dist-Balasore now Asst. Engineer under suspension is reinstated into Government Service with effect from the date, he actually joins duty.

On reinstatement, Sri Sahoo is posted as Asst. Engineer (Estimator), Office of the Rairangpur (R&B) Division, Dist-Mayurbhanj.

Necessary orders for considering the period of his suspension will be issued after finalisation of above Disciplinary Proceedings and Vigilance Case initiated against him.

Further, he is hereby cautioned not to influence the witnesses of the aforementioned Vigilance Case and Disciplinary Proceedings.


