

**Sub:- Amendment of OPWD Code with regard to Restructuring of Odisha Engineering Service Cadre (OES).**

After careful consideration, Government have been pleased to amend the relevant Paras in the OPWD Code keeping in view the restructuring of Odisha Engineering Service Cadre as mentioned below;

- i. An Additional Chief Engineer shall remain in charge of a Circle in place of the present provision of Superintending Engineer and he shall be called as Circle Officer (**Para.2.2.15** of OPWD Code, Volume-I).
  - ii. Chief Engineer shall be the Director of Designs in place of the present provision of the Director of Designs or Superintending Engineer (**Para.2.2.24** of OPWD Code, Volume-I).
  - iii. A Superintending Engineer or an Executive Engineer shall remain in charge of a Division in place of the present provision of Executive Engineer, and both shall be called as Divisional Officer (**Para.2.2.25** of OPWD Code, Volume-I).
  - iv. An Assistant Executive Engineer shall remain in charge of a Sub-Division and shall be called as Sub-Divisional Officer (**Para.2.2.61** of OPWD Code, Volume-I).
  - v. A Junior Engineer or an Assistant Engineer shall remain in charge of a Section who shall be designated as Section Officer (**Para.2.2.64** of OPWD Code, Volume-I).
2. The changes shall have overriding effect to anything contrary mentioned in the OPWD Code.
  3. This shall take effect from the date of issue of the Office Memorandum.
  4. This has been concurred in by Finance Department vide their File No.FIN-WF-I-MISC-0021-2019.


